Rule 2711 Compliance Letter to Clients REIT Growth and Income Monitor

During the first quarter of 2009, the REIT Growth and Income Monitor issued recommendations on 131 companies, of which 37% were BUY recommendations, 25% were SELL recommendations, and 38% were HOLD recommendations.
